PCSC VACANCIES – 2023 & 2024

The positions of twelve Presidents of CISM Sports Committees will be vacant, as below:

- **for the term 2023-2027**, starting from the CISM General Assembly & Congress in 2023:

Orienteering and **Wrestling**.

- **for the term 2024-2028**, starting from the CISM General Assembly & Congress in 2024:

Basketball, **Boxing**, **Equestrian**, **Football**, **Golf**, **Judo**, **Aeronautical Pentathlon**, **Parachuting**, **Shooting**, and **Volleyball**.

Article 4.10. President of CISM Sport Committee (Approved during the Extraordinary CISM Board of Directors Meeting 2022 by VTC on 21st June 2022)

A. The criteria for selection to a president of a "CSC" are the following:

1. Is an officer from a CISM member nation on active duty in the Armed Forces for at least two (2) more years after his/her appointment;
2. Has a thorough knowledge of the specific sport;
3. Should have previous CISM experience, preferably from the CSC of that sport;
4. Has a good possibility to build contact with the international and national sports federations, and with CISM delegations;
5. Is financially fully supported by his Delegation to attend all official meetings and any other activity in furtherance with his mission, particularly the CISM Championships, as well as to carry out a preliminary visit to the Organizing country of his sport's Military World Championship a few months before the start of the Championship; and
6. Is fluent in English.

B. All Presidents CSC are appointed by the BoD for a flexible period of four years. A president in function may stand for re-election.

C. On the 1st January of the year before the end of his/her mandate, the candidature to succeed him/her is officially announced by the CISM Secretary General. After selection by a selection commission, the Secretary General will present the candidates for approval by the BoD. The new PCSC's will be announced during the CISM General Assembly and on the CISM homepage.

D. The selection commission is composed of:

- the CISM Secretary General (Chairman)
- President of the CISM Sports Commission
- BoD-member (when the President of the Sports Commission is not a BoD-member)
- Current PCSC of the sport in question
- CISM Sports Director
- PCSC-manager (Secretary)

E. In recognition of outstanding achievements or in consideration of special sport perspectives, the Secretary General may request the extension of a PCSC mandate to the selection commission and with approval of the relevant Chief of Delegation. The announcement of the confirmation of the PCSC for the further mandate is given during the CISM General Assembly.

F. Any interested Officer, meeting the listed criteria for selection, must send an application file to the CISM Secretary General, through his/her delegation.
